BY-LAW #153-1

A BY-LAW TO AMEND BY-LAW #153, A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK

THE COUNCIL OF THE TOWN OF WOODSTOCK, UNDER AUTHORITY VESTED IN IT BY SECTION 11(1)(L) OF THE MUNICIPALITY ACT, R.S.N.B., CHAPTER M-22 ENACTS AS FOLLOWS;

TITLE

THIS BY-LAW MAY BE CITED AS A BY-LAW TO AMEND BY-LAW #153, A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK.

DEFINITION

- 1. BY-LAW #153, A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK IS HEREBY AMENDED BY ADDING THE FOLLOWING TO DEFINITION, SECTION 1.
 - 1. IN THIS BY-LAW:
 - F) "PERSON" SHALL INCLUDE PERSONS, CORPORATIONS, LIMITED COMPANIES, PARTNERSHIPS OR SOCIETIES.
 - G) "TRAILER" MEANS EVERY DEVICE IN, UPON OR BY WHICH PROPERTY IS OR MAY BE TRANSPORTED OR DRAWN BY A MOTOR VEHICLE AND INCLUDES REFRIGERATION OR HEATED UNITS FOR THE PURPOSE OF PRESERVING PROPERTY.
 - H) "LOADING/UNLOADING" MEANS THE REMOVAL OF PROPERTY FROM A TRAILER OR THE PLACING OF PROPERTY IN OR UPON A TRAILER.

AMENDMENTS

- 2. BY-LAW #153, A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK IS HEREBY AMENDED BY ADDING THE FOLLOWING TO SECTION 2.
 - 2. M) THE LOADING AND / OR UNLOADING OF A TRAILER BETWEEN THE HOURS OF 11:00 O'CLOCK IN THE AFTERNOON AND 7:00 O'CLOCK IN THE FORENOON OF THE NEXT FOLLOWING DAY.
 - N) THE OPERATION OF A GARBAGE DUMPSTER EITHER FOR THE REMOVAL OF GARBAGE OR THE PLACING/REMOVAL OF A DUMPSTER BETWEEN THE HOURS OF 11:00 O'CLOCK IN THE AFTERNOON AND 7:00 O'CLOCK IN THE FORENOON OF THE NEXT FOLLOWING DAY.
 - O) THE IDLING, RUNNING, REVVING OF AN ENGINE OF A PARKED MOTOR VEHICLE

OR A REFRIGERATION OR HEATING UNIT IN A PARKED TRAILER WITHIN BOUNDARIES OF THE TOWN OF WOODSTOCK EITHER ON PUBLIC OR PRIVATE PROPERTY BETWEEN THE HOURS OF 11:00 O'CLOCK IN THE AFTERNOON AND 7:00 O'CLOCK IN THE FORENOON OF THE NEXT FOLLOWING DAY.

- 3. BY-LAW #153, A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK IS HEREBY AMENDED BY DELETING SECTION 4 AND SUBSTITUTING A NEW SECTION 4 AS FOLLOWS:
 - 4. EXCEPT AS OTHERWISE HEREIN PROVIDED, NO PERSON SHALL ALLOW PROPERTY BELONGING TO THEM OR UNDER THEIR CONTROL TO BE USED SO THAT BETWEEN THE HOURS OF 11:00 O'CLOCK IN THE AFTERNOON AND 7:00 O'CLOCK IN THE FORENOON OF THE NEXT FOLLOWING DAY THE EMISSION OF SOUND OR SOUNDS RESULTING FROM AN ACT AS LISTED IN SECTION 2 WHICH DISTURBS THE COMFORT OR THE REPOSE OF OTHER PERSONS IN THE VICINITY OF SUCH PROPERTY.
- 4. BY-LAW #153. A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK IS HEREBY AMENDED BY ADDING THE FOLLOWING TO SECTION 5.
 - F) NOISES IN CONNECTION WITH ACTIVITIES, WORK OR EQUIPMENT INCLUDING MOTOR VEHICLES AND TRAILERS LOCATED WITHIN LAND ZONED AS INDUSTRIAL.
 - G) NOISES CAUSED BY MOTOR VEHICLES AND EQUIPMENT OPERATED BY PRIVATE INDIVIDUALS, CONTRACTORS ENGAGED IN THE REASONABLE EXECUTION OF SNOW REMOVAL, SNOW PLOWING, SALTING AND SANDING OPERATIONS.
 - H) NOISES CAUSED BY MOTOR VEHICLES, TRAILERS DURING LOADING, UNLOADING ACTIVITIES ON SUNDAY BETWEEN THE HOURS OF 12 O'CLOCK AND 5 O'CLOCK IN THE AFTERNOON.

OFFENCE

4. BY-LAW #153, A BY-LAW RESPECTING NUISANCES WITHIN THE TOWN OF WOODSTOCK IS HEREBY AMENDED BY DELETING SECTION 6 AND SUBSTITUTING A NEW SECTION 6 AS FOLLOWS.

ENFORCEMENT AND PENALTIES

- 6. (a) EVERY PERSON WHO VIOLATES ANY PROVISION OF THIS BY-LAW OR WHO KNOWINGLY ALLOWS A VIOLATION OF ANY PROVISION OF THIS BY-LAW TO TAKE PLACE ON PROPERTY OWNED OR LEASED BY THEM IS GUILTY OF AN OFFENCE.
 - (b) A PERSON WHO VIOLATES ANY PROVISION OF THIS BY-LAW COMMITS AN OFFENSE PUNISHABLE UNDER PART II OF THE PROVINCIAL OFFENCES PROCEDURE ACT AS A CATEGORY B OFFENCE.
 - (c) IF A PERSON CONTINUES TO CARRY ON ANY OF THE ACTIVITIES SET OUT IN THIS BY-LAW AFTER DIRECTED BY A PEACE OFFICER TO CEASE AND DESIST, THAT PERSON

IS GUILTY OF A SEPARATE OFFENCE AND A SEPARATE CHARGE AND OR CHARGES MAY BE LAID UNTIL SUCH TIME AS THE ACTIVITY IS STOPPED.

- (d) EVERY PERSON CHARGED WITH AN OFFENCE UNDER THIS BY-LAW MAY, ON OR BEFORE THE DATE A CHARGE PERTAINING TO THE OFFENCE HAS BEEN LAID IN PROVINCIAL COURT, MAKE A VOLUNTARY PAYMENT IN THE AMOUNT AS STATED AS A CATEGORY B OFFENCE UNDER THE PROVINCIAL OFFENCES PROCEDURE ACT, TO THE TOWN OF WOODSTOCK AS FOLLOWS.
 - (i) IN PERSON AT THE OFFICE OF THE WOODSTOCK POLICE FORCE, IN CASH OR BY CERTIFIED CHEQUE OR MONEY ORDER PAYABLE TO THE TOWN OF WOODSTOCK; OR
 - (ii) BY MAIL TO: WOODSTOCK POLICE FORCE, 822 MAIN STREET, WOODSTOCK, NB E7M 2E8, BY CERTIFIED CHEQUE OR MONEY ORDER ONLY, PAYABLE TO THE TOWN OF WOODSTOCK; AT WHICH TIME THE TICKET OR TICKET NUMBER SHALL BE SURRENDERED TO THE WOODSTOCK POLICE FORCE AND SUCH PAYMENT SHALL BE DEEMED PAYMENT IN FULL.
